Due to strong demand, the Company upsized the offering of the Senior Notes from the originally announced volume of \leq 250 million. The Senior Notes have a term of seven years and an interest rate of 2.00% p.a. The Senior Notes will be issued under New York law and are expected to be admitted to trading on the Euro MTF Market on the Luxembourg Stock Exchange. Standard & Poor's and Moody's rated the Senior Notes with "BBB-" and "Ba1", respectively. The net proceeds from the issue of the Senior Notes will be used to refinance existing secured indebtedness of certain subsidiaries of the Company and for general corporate purposes including the acquisition of assets.
